The CLIENT acknowledges, covenants and agrees that the obligation of the CLIENT or law firm to pay the AGENCY is in no way contingent upon a result or investigative outcome or a payment from their client (if CLIENT is a Law firm).

AGENCY warrants to CLIENT that **Maya Information services**, and office Manager **Niv Elbaz** are, duly licensed in the State of Israel, agency license number 024935876, as required by law, to perform investigative and related services. AGENCY warrants to CLIENT that the services

shall be performed with the degree of skill and care that is required, and in conformity with the accepted professional standards prevailing in the private investigative industry at the time the services are performed. AGENCY further warrants to the Client that in performing the services it will comply with all known applicable local, state and Country laws, regulations, and rules including, without limitation, those pertaining to the confidentiality of sensitive information. CLIENT will hold the AGENCY harmless from and all damages, losses, costs, or expenses, including any and all attorney fees, suffered or incurred in connection with or arising out of claims based on investigative findings provided to the CLIENT. AGENCY will keep findings strictly confidential and will not disseminate or release any findings to third parties unless authorized by the CLIENT, or court ordered.

CLIENT agrees to give prompt (within 48 hours) written or telephonic notice of any legal proceeding, including, without limitation to, any civil action, administrative hearing or arbitration, in Which the findings of **Maya information services**, or any portion thereof, are to be used in a material issue.
